The transmission will shift through forward and reverse properly, the tires are in good shape with slightly worn tread, brakes operate properly, AC is not turning on or working, radio is operating properly, exterior is in overall good shape with some minor clearcoat peeling on the hood area, interior is also in good shape with a minor crack to the windshield, tailgate opens and latches properly, 4WD is operating correctly, please come inspect prior to bidding!!
