P0113- high input voltage reading from the Intake Air Temperature (IAT) sensor 1 circuit

P0103- Mass or Volume Air Flow A Circuit High Input

P0100- Mass Air Flow (MAF) circuit malfunction

P2112- Throttle Actuator Control System "Stuck Closed" condition

P2111- Throttle Actuator Control System malfunction
